REQUEST AND AFFIDAVIT FOR DEFERRED DISPOSITION WITH DRIVING SAFETY COURSE

I am entitled to request evidence material to any matter involved in my case. Requests must be made at the Coppell Police Department. I decline to request the evidence.

I waive my right to an attorney, a jury trial and to appeal. I plead **Guilty / No Contest** and request deferred disposition with driver's safety course under Code of Criminal Procedure Art. 45.0511.

I understand that I must:

1. Present a valid Texas driver's license or permit, not a commercial driver's license;
2. Present proof of financial responsibility (vehicle liability insurance);
3. Provide my driving record from the Texas Department of Public Safety which shows that I have not completed an approved driving safety course within the 12 months preceding the date of this offense;
4. Successfully complete an approved driving safety course and present a uniform certificate of driving safety course completion before 90 days; and
5. Pay court costs and an administrative fee to the court.

I understand that:

If I provide proof that I successfully completed a driving safety course and my driving record maintained by the Department of Public Safety shows I had not completed an approved driving safety course within 12 months preceding the date of offense, the charge will be dismissed. The court will report to the Department of Public Safety the completion date of the driving safety course for inclusion on my driving record.

If I fail to present proof of completion of the driving safety course and my driving record, the court will require my appearance at a show cause hearing. If I fail to appear, the court will impose the fine and will issue a capias pro fine warrant for my arrest. A record of the conviction will be sent to the Texas Department of Public Safety. **A conviction of an offense under a traffic law of this state or political subdivision of this state may result in the assessment on my driver's license of a surcharge under the Driver Responsibility Program.**

I state under oath that I am not taking a driving safety course or motorcycle operator training course under the statute on this date and I have not completed a driving safety course that is not shown on my driving record within the 12 months preceding the date of this offense.
