

All persons who allege inability to pay in accordance with the judgment will be required to bring the following documents to an Indigent Hearing Docket for the Judge's consideration:

Supporting documents required for Indigence Hearing:

- Past 2 years of Federal Income Tax Return
- Past 2 bank statements (total of 2 months)
- Past 2 pay stubs
- Proof of governmental financial assistance, if any
- Letter of unemployment disposition and benefit amount, if any.
- Completed **Financial Information Affidavit** (must be completed in full)

The court will:

- Take your oath on the **Financial Information Affidavit**
- Verify the information you have provided as true

Defendant must understand the following:

- False or inaccurate information on the **Financial Information Affidavit** could result in felony perjury
- Failure to appear or satisfy the judgment against you will result in the following actions:
 - A onetime fee of \$15 (Reimbursement Fee) will be added to each offense, if any portion of the fine and costs is paid on or after 31 days after the date of judgment as required pursuant to Section 133.103, Local Government Code.
 - No further extensions will be granted.
 - Default on due date will result in a warrant for your arrest
 - Default on due date may result in your driver license being flagged for non-payment
 - You will be reported to a collection agency and your balance will increase by 30%
